ORDINANCE NO. 2023-1

**TOWN OF ST. MATTHEWS
BUDGET ORDINANCE
FISCAL YEAR 2022 - 2023**

AN ORDINANCE TO PROVIDE BUDGET APPROPRIATIONS AND THE LEVYING OF TAXES FOR ORDINARY PURPOSES IN THE TOWN OF ST. MATTHEWS FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2022, AND ENDING SEPTEMBER 30, 2023, BY THE TOWN OF ST. MATTHEWS, AND TO PROVIDE FOR THE EXPENDITURE THEREOF, THROUGH AN AMENDED BUDGET.

WHEREAS:

- 1) Section 5-11-40 (c) of the South Carolina Code of Laws (1976), as amended, provides the authority to prepare an annual budget for all departments and agencies for the Town Government; and.
- 2) The annual budget shall be based upon estimated revenues and shall provide appropriations for Town operations for all departments, is hereby declared to be a part of this ordinance and is attached hereto; and.
- 3) Pursuant to the above noted section of the Code of Laws, total funds appropriated in Fiscal Year 2022-2023 for the above purposes estimated revenues and carry forward funds available for expenditures in Fiscal Year **2021-2022**.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE TOWN OF ST. MATTHEWS, SOUTH CAROLINA, DULY ASSEMBLED THAT:

SECTION 1: Funds appropriated herein are to be expended only in compliance with policies adopted by Council, or at Council's direction, as formulated and implemented by the Town Administrator, either existing or adopted.

SECTION 2: The Town Administrator shall be responsible for the administration of the budget following adoption.

SECTION 3: Council reserves the right to amend any appropriation contained herein during the fiscal year by addition to, deletion of, or transfer of any item; provided, that the total amended estimated expenditures do not exceed total anticipated revenue. Council may increase the total budgeted appropriations by adopting supplemental appropriation ordinances during the year and shall *cite* the source of revenue of expenditure in same; and,

SECTION 5: Appropriations are absolute. Department Heads shall not exceed the line item amounts budgeted without prior approval by the City Administrator. The City Administrator must approve use of contingency funds and transfers between line items within a department.

SECTION 6: Any and all revenues received by the Town, regardless of source, shall be remitted to the Town Clerk and must be credited to the general fund to supplement and provide sufficient funding for all ordinary Town purposes. The only exceptions being those

revenues, which are received for a specific purpose and are mandated by State or Federal Law requiring funds to be accounted for separately.

SECTION 7: Such funds as are herein appropriated as a contribution, donation, or support of any agency organization shall be requested in writing by such agency or organization. Council reserves the right to request a copy of the agency's or organization's financial documents prior to any disbursements.

SECTION 8: Contracts voted on by Council must be approved by the Town Administrator.

SECTION 9: Any funds not expended during the fiscal year can be carried forward to subsequent years and excess of revenues over expenditures may accrue to the fund balance of the general fund. The only exceptions being those revenues which are received for a specific purpose and are mandated by State or Federal Law requiring funds to be accrued and carried forward.

SECTION 10: Adoption of Attachments (A). – Administrator Recommendations for FY22/23, (B). Utility, Water, Sewer, Garbage and Associated Fee Sheets and (C). Millage and Tax Credit Factor Letter.

SECTION 11: Capital assets owned by the Town of St. Matthews shall not be sold, rented, leased, optioned, disposed, or destroyed without prior approval of Town Council.

SECTION 12: Any prior Budget Ordinance or any section, paragraph, sentence, clause, or phrase of any prior Budget Ordinance that may be in conflict with this Ordinance are hereby declared to be invalid.

SECTION 13: If any section, paragraph, sentence, clause, or phrase of this Ordinance shall be declared unconstitutional by the valid judgment or decree of any Court of competent jurisdiction, such unconstitutionality shall not affect any of the remaining phrases, clauses, sentences, paragraphs, and sections of this Ordinance.

SECTION 14: This notice is given by the Town of St. Matthews under the requirements of SC Code of Laws, Section 5-11-40.

The total revenues from the 2021-2022 current operating fiscal year are \$2,090,343 the total expenditures from the 2021-2022 current operating fiscal year are \$1,868,377.

The proposed total projected revenues for the 2022-2023 fiscal year are \$2,090,343; the proposed total operating expenditures for the 2022-2023 fiscal year are \$1,868,377.

The estimated percentage of increase in the operating budget between the current 2021-2022 fiscal year and the proposed 2022-2023 fiscal year is 0%.

The current millage for the 2021-2022 fiscal year is 92.17.

The estimated millage for the 2022-2023 fiscal year is 92.17.

The budget is balanced by use of carry over funds, fund balance and other municipal and state revenue. ***Note: All number are subject to amendment due to pending past audit findings ***

Mayor Carson-Peterson called the meeting to order at 6:00 p.m. The Mayor opened the meeting in prayer followed by the Pledge of Allegiance.

Agenda:

Staff Budget Recommendations: Tim Cornelison started the work session by giving the Council Members a detail breakdown of each department proposed 2022-2023 budget. The budget was configured for a 4.7 percent cost of living increase for all employees. Mr. Cornelius explained where the funds were pulled to budget each department.

Review of Proposed 2022-2023 Budget: The budget would include twelve full time employees (12) and four (4) part-time employees. A proposed budget increase starting pay for Police Officers to seventeen dollars and forty-eight cents (\$17.48) which would start new certified officers with thirty-eight thousand (\$38,000.00) a year. That thirty-eight thousand (\$38,000.00) is based on a twelve (12) hour shift. Also, the Police Department is switching weapons to Glock, model 45 Mos Gen 5. The Police Fleet Vehicles is on hold due to no response from Enterprise. It was requested, to increase the Firemen salary to fifteen-dollar (\$15.00) per hour based on a twenty-four (24) hour shift to match the Police salary of \$38,000.00. There was another proposal to include five thousand (\$5000.00) to offset the cost for Community Events.

Proposed Millage Increase: Charlie Barrineau spoke with Town Administrator to discuss millage increase.
Discussion, Questions and Answers: During this session the CPA and Town Administrator answered all questions and concern the Council Members had at that time.

On Tuesday, September 20th, 2022, it was a continuation from Monday night work session with a more in-depth line-item discussion for each department. Mr. Jacobs asked could the budget be configured at 3.00 percent to have options on deciding the new cost of living increase.

The meeting was adjourned approximately 7:25 pm on Monday, September 19th, 2022. On Tuesday, September 20th, 2022, the meeting was adjourned approximately 7:15 pm.
