Mayor Pro-Tempore, Mr. Jacobs called the meeting to order at 6:00 p.m. Mr. Jacobs opened the meeting in prayer followed by the Pledge of Allegiance.

Citizens Input: No citizens signed to speak.

The Budget Hearing opened at 6:02 pm.

Administrator's Budget Recommendation FY 2022-2023

- No Mileage Increase: Will remain the same for Fiscal Year 2022-2023.
- No Water/Sewer Rate Increase: Mr. Jacobs entertained a motion not to have water/sewer increase until next year. It was moved by Ms. Prickett and seconded by Ms. Bennett. The motion was carried unanimously.
- 4.7 % pay increase for all employees: Mr. Jacobs entertained a motion to increase employees
 cost of living rate to 3.5 percent. It was moved by Ms. Prickett and seconded by Mr. Carroll. The
 motion was carried unanimously.
- 4. \$250.00 Christmas Bonus for all employees: Mr. Jacobs entertained a motion to give each employee a two-hundred-dollar (\$200.00) Christmas Bonus. It was moved by Ms. Bennett and seconded by Mr. Carroll. The motion was carried unanimously.
- Increase starting pay for Police Officers to \$17.48 per hour: Mr. Jacobs entertained a motion to increase new officers and current officers starting pay to \$17.48 per hour. It was moved by Ms. Prickett and seconded by Mr. Carroll. The motion was carried unanimously.

- Increase Firemen Salary to \$ 15.00 per hour. Mr. Jacobs entertained a motion to increase
 Firemen Salary to \$15.00 per hour. It was moved by Ms. Prickett and seconded by Ms. Bennett.
 The motion was carried unanimously.
- Include \$5,000.00 in the Budget for Community Events: Mr. Jacobs entertained a motion to include \$5000.00 to the Fiscal Year 2022-2023 budget for Event Committee. It was moved by Ms. Prickett and seconded by Mr. Carroll. The motion was carried Unanimously.
- Police New Weapons: Mr. Jacobs entertained a motion to accept the invoice in the amount of \$5,640.55 for new weapons. It was moved by Ms. Prickett and seconded by Ms. Bennett. The motion was carried unanimously.

The regular Town Council Meeting proceeded after 2022-2023 Budget Hearing. Mr. Jacobs entertained a motion for the approval of Prior Meeting Minutes. It was moved by Ms. Bennett and seconded by Ms. Prickett. The motion was carried unanimously.

Mr. Jacobs then entertained a motion to accept the agenda with item number four (4) SC DHEC – Enforcement moved to Executive Session. Mr. Jacobs made a motion to accept he Agenda with the necessary correction. It was moved by Ms. Pricket and seconded by Ms. Bennett. The motion was carried unanimously. Mr. Jacobs then entertained a motion to accept the Police, Fire, and Animal reports. It was moved by Ms. Prickett and seconded by Ms. Bennett. The motion was carried unanimously.

Citizens Input

Audrey Murph – She was concerned about a tree being uprooted from the roots across from her house.

Jacob Hair: Town Ordinance- when was the last successful Audit conducted and what was the outcome.

Ruth Govan: On Agnes Street she is having issues with drainage line and rodents on her property. Ms. Sumpter from DOT commented that the property owner is responsible and DOT only clean the right away. She explained that DOT can't do anything without the homeowner permission. Ms. Prickett made a suggestion to seek assistance from the community to assist Ms. Govan.

Town Council News: Ms. Bennett: She was concerned that the County has a virtual option for meetings and could the Town have the same option. Also, is Upper Muller owned by John Ford because inside the fence the grass needs to be maintained. Spokesperson from DOT commented that they don't have the right away but they would check on the issue.

Mr. Carroll: Expressed positive feedback with the progress of Lake Inspiration.

Calhoun County Community Development Director – Tyrone Dantzler – Wants to make sure the quality of life is show cased in the Calhoun County. Mr. Dantzler would like to work with municipalities to develop sewer projects for this area.

Mayor Helen Carson-Peterson entertained a motion to assist The Friends of St. Matthews with A \$250.00 donation. It was moved by Mr. Webb and seconded by Ms. Prickett. The motion was carried unanimously.

SC DHEC-Enforcement- will be discussed in Executive Session.

Report of the Town Administrator

Event Committee – The Christmas parade is scheduled for December 10, 2022. Chief of Police – On 10/29/2022 the Police Department will do a movie night for Halloween featuring Ghost Busters II. They will be serving popcorn, drinks, and hotdogs.

Fire Chief Report – Corey and Ross are doing a good job running the Fire Department while Chief Sandlin is on leave. The Federal Government added another 90 million to the grant cycle and hopefully the Fire Department will be successful in obtaining grant funds.


