Mayor and Council News

1. Recognition of Town Employees: The Mayor acknowledged the birthdays of Town Employees for the month of January: Mr. Lewis on January 4th, Mr. Carroll on January 29th, and Mr. Sandlin on January 30th.

2. Town Council News:

Mayor Carson-Peterson: The Mayor wished everyone a Happy and Prosperous New Year. She thanked Ms. Warren and Mr. Wilson for assisting her with the Coat Drive presentation at St. Matthews K-8. She felt it was a huge success. She also wants to inform the citizens that the S.C. Stay Program application ends on January 30th, 2023.

Ms. Bennett: She wished everyone a Happy New Year. She was concerned that the past Council Woman, Ms. Archie-Simmons, is still on the Town webpage. Ms. Warren informed her that the new webpage is in the process of being updated.

Mr. Carroll: The Christmas parade turned out lovely. He was glad everyone made it through the cold weather we experienced during December.

Ms. Riley: She commented that the lighting issues have improved. On Means Street, her vehicle bogged down near her mother's Home. Ms. Riley is still inquiring about the sweeper, and Ms. Warren informed her that she would meet with the County on Friday.

Ms. Shuler-Guinyard: Wishes everyone a Happy New Year. She asked Ms. Warren if the issue with Mr. Bull was cleared up. Ms. Warren stated she couldn't get in touch with Mr. Bull and that he doesn't have a water or sewer contract. Ms. Peterson — Carson asked did he pay taxes, and Ms. Warren stated she would check with Calhoun County Treasurer Office. Ms. Warren stated if she couldn't get in touch with Mr. Bull, the Town would pick up the debris and charge Mr. Bull for the pick-up.

3. Dr. William Molnar, Lower Savannah Council of Governments: Dr. Molnar congratulated Mr. Jacobs as a newly elected member of the Board of Lower Savannah Council of Government. He also presented Mayor Carson-Peterson with a plaque for ten (10) years of service with the Lower Savannah Council of Government. Dr. Molnar will come back later and speak about State and Federal programs.

- 4. Town and Country parking Lot: Ms. Warren spoke with Mr. Mohammed Hloubi, informing him that his offer was denied. He asked if he could receive more lighting around his establishment.
- 5. Town Signage: Ms. Warren is still awaiting a response from Mr. Holbert.
- 6. Potential Economic Development Matter: Will be discussed in Executive Session.
- 7. SCDHEC Sanitary Survey: The Town received a satisfactory rating on the water report.
- 8. Meeting with USDA Representative: Mayor Carson-Peterson and Ms. Warren met with a representative from the USDA to discuss projected projects for the Town. Ms. Warren has the application to proceed in getting the necessary funds.

- 9. Calhoun County High School Marching Band: The band requested a donation to attend the Atlanta Hawks game. The Mayor entertained a motion to give the Calhoun County marching Band a donation to assist them in going to the Atlanta Hawks game. It was moved by Mr. Jacobs and seconded by Ms. Pricket. Ms. Shuler-Guinyard opposed the motion. Mr. Jacobs suggested using the funds from the Recreation Budget, and Ms. Warren suggested it come from the Event Community Budget. Ms. Bennett suggested donating five hundred dollars (\$500.00) to help the band on their trip. Ms. Bennett motioned to allocate the Calhoun County High School band seven hundred fifty dollars (\$750.00) to assist on their trip to the Atlanta Hawks game. Mr. Jacobs and Ms. Shuler-Guinyard opposed the motion.
- 10. Demolition and Beautification Projects: A Special Called meeting will be held on January 09, 2023, at 6:00 pm to accept the bid request and to go through each application to get the amount awarded to each applicant.

- 5. Chief of Police: The Chief of Police stated that Cadet Lewis finished his four (4) weeks of testing, and Cadet Darby was delayed on testing but has also finished. They both are waiting to attend the Police Academy.
- 6. Fire Chief Report: The Fire Department received a call from a resident, and the homeowner didn't have a fire but had several extension cords plugged into one outlet that was

Mr. Carroll said, we should allow the demolition without having the property owner to pay. If the bid amount is greater than \$6900.00 the property owner would pay the difference.

The Mayor entertained a motion to accept the bid as written by Mitchell's Tree Service. It was moved Mr. Carroll and seconded my Ms. Bennett. The motion was carried unanimously.



Install smoke alarms on every level of your home.

Yard Waste Regulations

Garbage Pick-Up And **Utility Bills**

Town of St. Matthews is responsible for:

- 1.Tree limbs, branches, underbrush, hedge trimmings, leaves, pine straw, grass and other yard waste resulting from normal yard maintenance shall be placed between the sidewalk and curb close to the street for collection.
- 2. Yard waste of size and weight which will fit in plastic trash bags must me secured in plastic bags before it will be removed by the Town.
- 3.Tree branches shall be no greater than four inches in diameter and four feet in length.
- 4.Piles of Yard Trash shall be no larger than 5x5x5x5.
- 5. Yard Trash inconsistent with Town specifications will receive a "Notice" of Illegal Pile.

Special exceptions must be approved by Town subject to the surcharge.

Garbage Pick-Up

Garbage Pick-Up is on Mondays. Please have carts out to the curb on Sunday evenings or before 6:00 a.m. Monday morning.

The only Holidays affected by the Monday schedule in 2023 will be Labor Day (September 4th). Garbage will be picked up the following day and Christmas Day (December 25th) Garbage will be picked up the following day!

All Carts are to be returned to the residence within 24 hours of pick up...non compliance may result in a \$25.00 citation.

Utility Bills

All utility bills are due by the 15th of each month. Payments received after the 15th will be charged a 15% late fee penalty. If bills are not paid by the 30th of the month they will receive an additional \$20 fee and added to the Town's disconnect list. Customers whose services have been disconnected will not be restored until their account is in good standing.

All Town customers shall Administration and will be have an identifiable "shutoff" valve, NOTE: Only Town staff is allowed to enter into Town Meter Boxes. Unauthorized tampering may result in citations.
