The Mayor closed the Public Hearing at 6:15 p.m. Mr. Jacobs entertained a motion to assess property owners a penalty of \$500. 00 for violating the Nuisance Abatement Ordinance. Ms. Prickett seconded the motion. The motion was carried unanimously.

Citizens Input - There were no citizens present wishing to speak.

Rizen Gazelle—Amber Lewis and Ashby Ocain—Ms. Ashby Ocain from Rizen Gazelle, a nonprofit organization that started in March, is looking at ways to give back to the community. The organization has partnered with the Department of Social Services to help families in need. The Rizen Gazelle organization accepts donations for monetary items, clothes, and furniture. It is a 501(C)3 organization and will provide a receipt for all donations.

Mohammed Hloubi, Town and Country Restaurant - Mr. Mohammed Hloubi expressed interest in purchasing the Town and Country Restaurant parking lot from the Town of Saint Matthews.

Calhoun County Use of Municipal Court – Ms. Warren will meet with the County Administrator to discuss the utilization of the Municipal Court. Ms. Warren asked for permission from the Council to speak with the County regarding the use of the Municipal Court. Ms. Bennett entertained a motion granting Ms. Warren permission to talk with the County, and Ms. Prickett seconded the motion. The motion was carried unanimously.

South Carolina State Guard—The Council decided to hold the Resolution until the Local Government Affairs Officer, CW4 Angela Stringer, could explain the South Carolina State Guard's purpose.

SCRWA - Voting Delegate - Ms. Warren requested that Mr. Wilson be the voting delegate for the

St. Matthews Farmer's Market—Ms. Parker, along with students from South Carolina State University and the Department of Agriculture, would like to use the Town Pocket-it-Park to sell farmers' fruits and vegetables. The event will take place every second Saturday of the month.
